- 1. AGREEMENT TO FOLLOW DIRECTIONS. I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by Springfield Drifters & Bushnell University, or the employees, representatives or agents of Springfield Drifters & Bushnell University.
- 2. ASSUMPTION OF THE RISKS AND RELEASE. I recognize that there are certain inherent risks associated with the above described activity and I assume full responsibility for personal injury to myself and (if applicable) my family members, and further release and discharge Springfield Drifters & Bushnell University for injury, loss or damage arising out of my or my family's use of or presence upon the facilities of Springfield Drifters & Bushnell University, whether caused by the fault of myself, my family, Springfield Drifters & Bushnell University or other third parties.
